# **Turning Prohibition Regulation Housekeeping on Manse Road**

### **SUMMARY**

This staff report is about a matter for which the Community Council has delegated authority from City Council to make a final decision.

This report for Manse Road details the townhouse private driveway turning prohibition regulation change required to rescind the unsigned right-turn prohibition onto Manse Road.

Community Council's approval of the regulation amendments will prevent these orphaned unsigned regulations from being unnecessarily consolidated into the Toronto Municipal Code.

#### RECOMMENDATIONS

#### **Transportation Services recommends that:**

- 1. Scarborough Community Council rescind the prohibited turn regulations, as identified in Appendix 1 of the report dated July 20, 2010, entitled "Turning Prohibition Regulation Housekeeping on Manse Road" from the Director, Transportation Services, Scarborough District.
- 2. Scarborough Community Council pass or amend the appropriate by-law(s) accordingly.

### **Financial Impact**

There is no financial impact associated with this report.

#### **ISSUE BACKGROUND**

There are currently no signed right-turning prohibitions onto Manse Road from the private driveway to the town house complex at 443 Manse Road, located 61 metres north of Kingston Road. However, there are legacy regulations in place under Scarborough By-law 23503 for westbound right-turn prohibitions at this location.

These orphan regulations are the remnants of a now defunct traffic management scheme from the City of Scarborough where a right turn prohibition sign was installed in an attempt to mitigate traffic infiltration through the community. However, these signs have since been removed but these regulations along Manse Road were never rescinded.

#### COMMENTS

The regulations will be amended to remove the reference to the unposted westbound right turn prohibition. There will be no change in any currently posted traffic regulations.
