SUMMARY

This staff report is about a matter that Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval to rescind the alternate side parking on Awde Street and introduce a Thursday parking regulation.

This parking regulation change is in keeping with City's Clean and Beautiful City initiative to enable regular cleaning of both sides of the street by mechanical street sweepers.

RECOMMENDATIONS

Transportation Services recommends that Toronto and East York Community Council:

- 1. Rescind the "No Parking Anytime, from the 1st day to the 15th day of each month, April 1st to November 30th; and from December 1st of one year to March 31st of the next following year", regulation on the west side of Awde Street between Fisher Street and the southerly limit of Awde Street.
- 2. Rescind the "No Parking Anytime, from the 16th day to the last day of each month, April 1st to November 30th", regulation on the east side of Awde Street, between Fisher Street and the southerly limit of Awde Street.

- 3. Rescind "Parking by permit only", from 12:01 a.m. to 7:00 a.m., all times, on the east side of Awde Street, from 30.5 metres north of Dundas Street West to Fisher Avenue.
- 4. Introduce a "No Parking Anytime, except each Thursday, from April 1st to November 30th", regulation on the west side of Awde Street, between Fisher Street and the southerly limit of Awde Street.
- 5. Introduce a "No Parking, each Thursday, from April 1st to November 30th", regulation on the east side of Awde Street, between Fisher Street and the southerly limit of Awde Street.
- 6. Introduce "Parking by permit only", from 12:01 a.m. to 7:00 a.m., all times, except each Thursday, from April 1st to November 30th, on the east side of Awde Street, between Fisher Street and southerly limit of Awde Street.
- 7. Introduce "Parking by permit only", from 12:01 a.m. to 7:00 a.m., each Thursday, from April 1st to November 30th, on the west side of Awde Street, between Fisher Street and southerly limit of Awde Street.

ISSUE BACKGROUND

Councillor Adam Giambrone, on behalf of area residents, has requested Transportation Services investigate rescinding the alternate side parking regulation on Awde Street, between Fisher Street and the south limit and introduce a Thursday parking regulation.

COMMENTS

Awde Street is a local roadway operating two-way with a pavement width of 7.1 metres. The speed limit is 50 km/h. There is no TTC service on Awde Street.

Parking currently alternates bi-monthly between April 1st and November 30th, and reverts to exclusive parking on the east side from December 1st to March 31st. Permit parking is in effect from 12:01 a.m. to 7:00 a.m., daily.

Introducing a "Thursday" parking regulation on Awde Street involves prohibiting parking on the side of the street where parking is normally allowed and transferring parking to the opposite side of the street for that day. This will not inconvenience residents.
