**SUMMARY**

---

This staff report is about a matter for which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting authority to rescind the one hour maximum parking regulation, from 8:00 a.m. to 6:00 p.m., on the north side of Adelaide Street West, between Strachan Avenue and Niagara Street.

This change will provide longer duration parking (3 hours maximum) for local residents and their visitors daily.

**RECOMMENDATIONS**

---

**Transportation Services recommends that Toronto and East York Community Council:**

1. Rescind the “One-hour maximum parking regulation, from 8:00 a.m. to 6:00 p.m.”, in effect on the north side of Adelaide Street West, between Strachan Avenue and Tecumseth Street.
2. Allow “One-hour parking, from 8:00 a.m. to 6:00 p.m.”, on the north side of Adelaide Street West, between Niagara Street and Tecumseth Street.

## ISSUE BACKGROUND

At the request of Deputy Mayor Joe Pantalone, Transportation Services' staff investigated rescinding the "One-hour maximum, 8:00 a.m. to 6:00 p.m.", parking regulation in effect on the north side of Adelaide Street West, from Strachan Avenue to Niagara Street to provide a longer duration parking for local residents and their visitors daily.

## COMMENTS

### Current Conditions

Adelaide Street West, between Strachan Avenue and Niagara Street is a collector roadway, operating in a one-way eastbound direction with a pavement width of 7.3 metres. TTC service does not operate on this section of Adelaide Street West. The following parking regulations are in effect on Adelaide Street West:

#### North side

- One-hour maximum parking regulation, from 8:00 a.m. to 6:00 p.m.; parking is allowed for a maximum period of three hours at other times, outside the hours of permit parking operation between 12:01 a.m. to 10:00 a.m..

#### South side

- Parking is prohibited at all times.

The local residents have requested the one-hour maximum parking regulation, from 8:00 a.m. to 6:00 p.m., on the north side of Adelaide Street West, between Strachan Avenue and Niagara Street be rescinded to provide a longer duration parking throughout the day.

## Resolution

Based on staff's investigation, the one-hour maximum parking regulation, from 8:00 a.m. to 6:00 p.m. on the north side of Adelaide Street West, between Strachan Avenue and Niagara Street can be rescinded.

Adoption of the recommendation contained in this report will enable residents and their visitors to park for a maximum period of three hours during the day.
