# SUMMARY

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to introduce overnight on-street permit parking on the east side of Wellesley Place, between Wellesley Street East and Wellesley Lane, under the operating hours of 12:01 a.m. to 8:00 a.m., 7 days a week.

Area residents requested the implementation of overnight on-street permit parking on the east side of Wellesley Place, between Wellesley Street East and Wellesley Lane, to accommodate their long term parking needs without being subject to tagging by Parking Enforcement.

# RECOMMENDATIONS

#### **Transportation Services recommends to Toronto and East York Community Council that:**

1. Schedule A of Municipal Code Chapter 925 be amended to incorporate Wellesley Place, between Wellesley Street East and Wellesley Lane, under the operating hours of 12:01 a.m. to 8:00 a.m., 7 days a week.

## **ISSUE BACKGROUND**

A request was received from Councillor Kyle Rae, on behalf of area residents for the introduction of overnight on-street permit parking on Wellesley Place, between Wellesley Street East and Wellesley Lane, with the operating hours of 12:01 a.m. to 8:00 a.m., 7 days a week.

# COMMENTS

Wellesley Place, between Wellesley Street East and Wellesley Lane, is a local roadway operating a two-way north/southbound direction with a pavement width of 7.3 metres. There is no TTC service on Wellesley Place, between Wellesley Street East and Wellesley Lane. Parking is allowed on the east side of Wellesley Place, between Wellesley Street East and Wellesley Lane for a maximum period of one hour between 8:00 a.m. to 6:00 p.m., and for a maximum period of three hours at all other times. Parking is prohibited at anytime on the west side of the street.

Under the provisions of Municipal Code Chapter 925, Permit Parking, we are required to conduct a poll of the residents to determine if there is support to introduce permit parking.

Ballots were mailed on August 25, 2009, with the last day for filing a response being September 23, 2009. The results of the poll are as follows:

Polling Summary

A field survey has determined that there are fifteen (15) potential on-street parking spaces available on the east side of Wellesley Place, between Wellesley Street East and Wellesley Lane.

The majority of area residents returned their ballots in favour of the introduction of overnight on-street permit parking on Wellesley Place, between Wellesley Street East and Wellesley Lane.
