Notice was given and a Public Hearing was held on Wednesday, November 18, 2009, as required by the Planning Act.

PURPOSE OF THE APPLICATION:

To construct a 2 1/2 storey addition to the rear and east side of the existing dwelling, as well as one-storey bay window addition to the front of the dwelling.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

1. Section 6(3) I(1), By-law 438-86

The maximum permitted gross floor area is 0.6 times the area of the lot (401.6 m²). The altered dwelling will have a gross floor area equal to 0.88 times the area of the lot (588.89 m²).

2. Section 6(3) Part II 3.B(II), By-law 438-86

The minimum required side lot line setback for the portion of the dwelling that exceeds a dept of 17 m is 7.5 m.

The 3.06 m portion of the dwelling that exceeds the 17 m depth will be located 1.2 m from the west side lot line and 1.35 m from the east side lot line.

3. Section 6(3) Part II 2 (II), By-law 438-86

The minimum required front yard setback is 7.89 m.

The altered dwelling will be located 7.04 m from the front lot line.

IT WAS THE DECISION OF THE COMMITTEE OF ADJUSTMENT THAT:

The Minor Variance Application is Refused

- The general intent and purpose of the Official Plan is not maintained.
