

**Sign Variance - 230 Richmond St E**

**SUMMARY**

This staff report is about a matter for which the Community Council has delegated authority from City Council to make a final decision.

This report reviews and makes recommendations on a request by Steve Wolowich of Astral Media Outdoor, L.P., on behalf of Phillip Galin of 1304543 Ontario Ltd., for approval of variances from Chapter 297, Signs, of the former City of Toronto Municipal Code to permit, for third party advertising purposes, replacement of an existing legal non-conforming illuminated ground sign located along Richmond Street East frontage of the property with a newly designed illuminated tri-vision ground sign containing a horizontally rotating scroll attribute at 230 Richmond Street East.

Staff recommends refusal of this application. The variances are major and not within the general intent and purpose of the Municipal Code.

**RECOMMENDATIONS**

**The Toronto Building Division recommends that:**

1. Toronto and East York Community Council refuse the request for variances permit, for third party advertising purposes, replacement



of an existing legal non-conforming illuminated ground sign with a newly designed illuminated tri-vision ground sign containing a horizontally rotating scroll attribute on the southwest corner of the property at 230 Richmond Street East.

**Financial Impact**

The recommendations in this report have no financial impact.

**ISSUE BACKGROUND**

The property is located east of George Street, on the north side of Richmond Street East in a RA zone. The applicant is seeking permission to replace, for third party advertising purposes, an existing legal non-conforming illuminated ground sign located along the Richmond Street East frontage of the property with a newly designed illuminated tri-vision ground containing a horizontally rotating scroll attribute with third party advertising at 230 Richmond Street East.

The sign does not comply with Chapter 297, Signs, of the former City of Toronto Municipal Code in the following ways:

Sign By-law Section and Requirements	Applicant's Proposal	Required Variance
1. Chapter 297-10D(8)	To install an illuminated ground sign containing third party advertising in the CR zone.	The proposed ground sign containing third party advertising is not permitted.
2. Chapter 297-10.B.(2)	To install an illuminated ground sign containing a horizontally rotating scroll copy attribute	The proposed sign contains an attribute that is a rotating scroll which is not specifically permitted.
3. Chapter 297-10F	The sign may be located less than 60.0m from other third party signs located in the vicinity.	A third party sign is required to have a separation distance of minimum 60.0m from other third party sign in the vicinity.

**COMMENTS**

At its meeting of April 2, 1996, the former City of Toronto Council passed By-law No. 1996-0172 to amend Chapter 297 of the Municipal Code to prohibit third party ground signs and pedestal signs in CR, MCR and RA zone districts. The regulations were aimed at reducing proliferation of third party signs in the mixed-use zone districts.

Third party illuminated tri-vision ground signs are not permitted on this site within the RA zoning. In zones where third party ground signs are permitted, the By-law requires a

minimum separation distance of 60m from other third party signs located in the vicinity. The proposed third party ground signs would not meet that requirement. A third party roof sign is located on top of the building at 262 Richmond Street East. Also, the Municipal Code does not allow replacement of sign attributes such as from a paper copy to a tri-vision system.

Staff can advise that the third party ground signs under the new sign by-law recently approved by Council are not permitted in this sign district and accordingly any approval under the new sign by-law would require a variance.

This application clearly contradicts the City's prohibition of ground signs and its clear objective to prohibit this type of signage under the current by-law. It is staff's opinion that permitting an illuminated, tri-vision type sign, for third party advertising purposes would undermine the clear intent of City policy and would not maintain the integrity and the spirit of the Municipal Code. It is staff's opinion that the proposed signs would diminish the objectives for quality urban design in this area.

Staff recommends refusal of this application. The variances are major and not within the general intent and purpose of the Municipal Code.

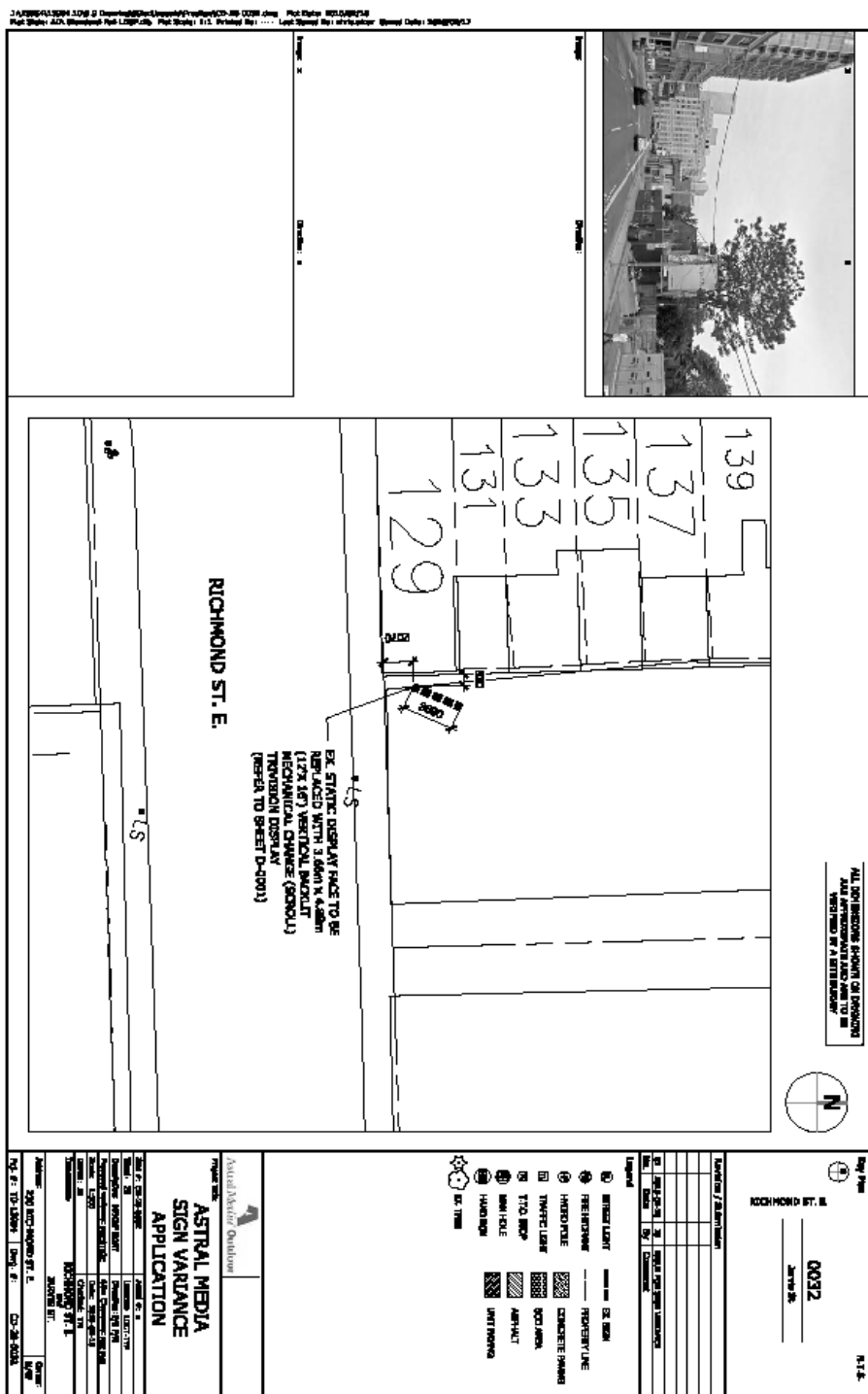
