Installation/Removal of On-Street Parking Spaces for Persons With Disabilities – April 2010

SUMMARY

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision. The purpose is to obtain approval for the installation/removal of a number of on-street parking spaces for persons with disabilities.

RECOMMENDATION

Transportation Services recommends that:

1. Toronto and East York Community Council approve the installation and removal of on-street parking spaces for persons with disabilities at the locations identified in the attached Appendix A.

ISSUE BACKGROUND

Transportation Services receives numerous requests for the installation and removal of on-street parking spaces for persons with disabilities. Some of these requests come directly from members of the public and others are received through the local Councillors' offices.

The installation of designated on-street parking spaces for persons with disabilities is a convenience provided for disabled persons and/or those who transport them, making it easier for them to find available parking as near as possible to their places of residence or intended destinations and reducing the distance that the disabled persons must walk. Delays in installing these requested on-street spaces may create hardships for disabled applicants.

Timely removal of designated on-street parking spaces for persons with disabilities when these on-street spaces are no longer required is necessary in order to maximize available on-street parking for other residents/motorists.

COMMENTS

Transportation Services staff have investigated the feasibility of installing and/or removing on-street parking spaces for persons with disabilities at the locations identified in the attached Appendix A to this report. None of these sections of roadway are served by TTC transit routes.

For locations where on-street disabled persons' parking spaces are being established, all applicants are holders of valid Accessible Parking Permits issued by the Ministry of Transportation and each designated space will not result in the loss of more than one on-street parking space for general use. Locations where on-street disabled persons' parking spaces are to be removed are the result of applicants moving, holding expired permits or no longer requiring these on-street parking spaces.

Appendix A

On-street parking spaces for persons with disabilities to be removed:

Ward	Location
14	Fermanagh Avenue, south side, between a point 32.8 metres east of Roncesvalles Avenue and a point 5.5 metres further east.
18	Armstrong Avenue, north side, between a point 116 metres east of Emerson Avenue and a point 5.5 metres further east, anytime from the 1 st day of each month to the 15 th day of each month, from Apr. 1 st to Nov. 30 th ; inclusive.
18	Armstrong Avenue, south side, between a point 111.5 metres east of Emerson Avenue and a point 5.5 metres further east, anytime from Dec. 1^{st} of one year to Mar. 31^{st} of the next following year, inclusive, and from the 16^{th} day to the last day of each month, from Apr. 1^{st} to Nov. 30^{th} ; inclusive.
18	Paton Road, north side, between a point 6.2 metres east of Campbell Avenue and a point 5.5 metres further east, anytime from Dec. 1^{st} of one year to Mar. 31^{st} of the next following year, inclusive, and from the 1^{st} day of each month to the 15^{th} day of each month, from Apr. 1^{st} to Nov. 30^{th} ; inclusive.
18	Paton Road, south side, between a point 16.6 metres east of Campbell Avenue and a point 5.5 metres further east, anytime from the 16^{th} day of each month to the last day of each month, from Apr. 1^{st} to Nov. 30^{th} , inclusive.
20	Albany Avenue, east side, between a point 118 metres north of Bloor Street West and a point 5.5.metres further north.
22	Oriole Gardens, south side, between a point 125 metres east of Oriole Road and a point 5.5 metres further east.
28	Spruce Street, north side, between a point 62.5 metres east of Sumach Street and a point 5.5 metres further east.

On-street parking spaces for persons with disabilities to be installed:

Ward	Location
18	Lindsey Avenue, north side, between a point 19.5 metres east of Gladstone Avenue and a point 5.5 metres further east, anytime from the 16 th day of each month to the last day of each month, from Apr. 1 st to Nov. 30 th , inclusive.
18	Lindsey Avenue, south side, between a point 23 metres east of Gladstone Avenue, and a point 5.5 metres further east, anytime from Dec. 1^{st} of one year to Mar. 31^{st} of the next following year, inclusive, and from the 1^{st} day of each month to the 15^{th} day of each month, from Apr. 1^{st} to Nov. 30^{th} , inclusive.
28	Spruce Street, north side, between a point 62.5 metres west of Sumach Street and a point 5.5 metres further west.
28	Winchester Street, south side, between a point 25 metres west of Metcalfe Street and a point 5.5 metres further west.
32	Craven Road, east side, between a point 84 metres north of Dundas Street East and a point 5.5 metres further north.
