Ballots were mailed out on August 31, 2009 with the last date for filing a response being September 29, 2009. The following is the poll result:

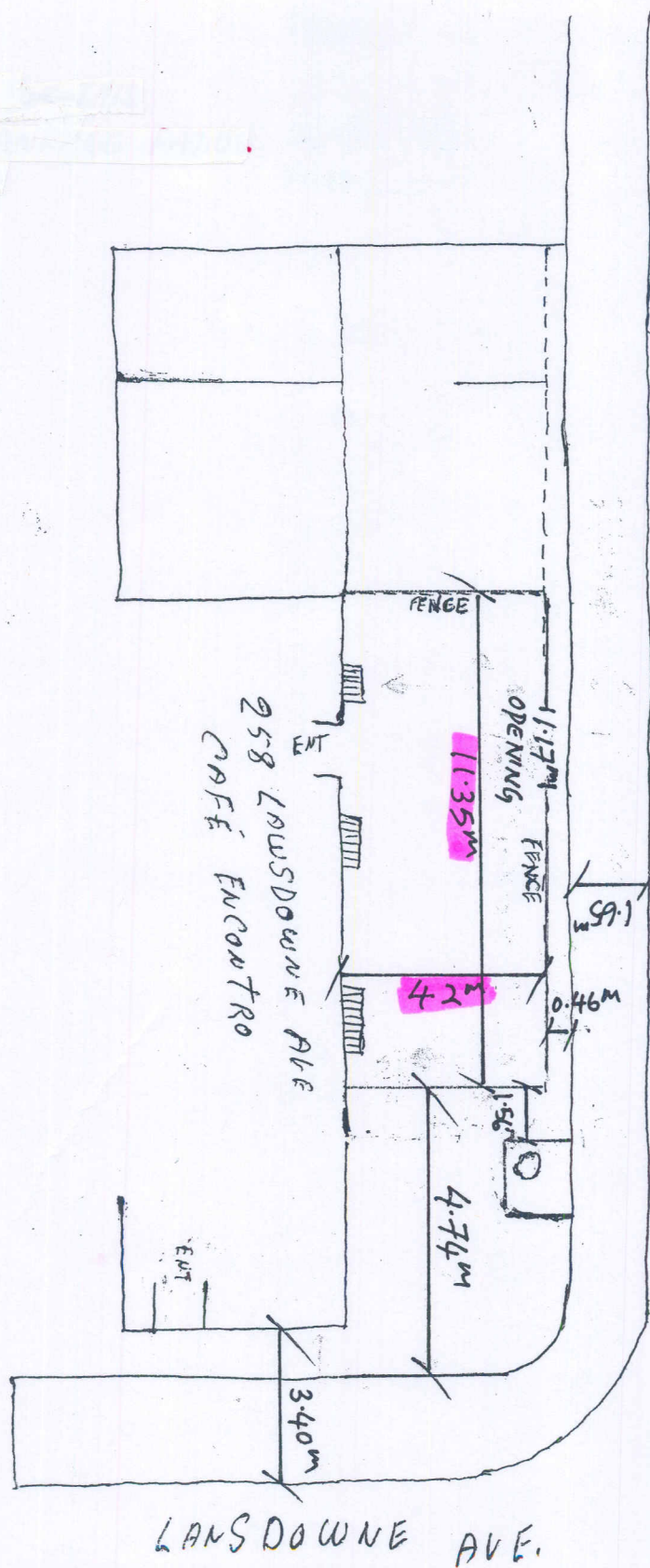
