**Introduction of Overnight On-Street Permit Parking –
Lynn Williams Street**

SUMMARY

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to introduce overnight on-street permit parking on the south side of Lynn Williams Street, between Pirandello Street and East Liberty Street, under the operating hours of 6:00 p.m. to 7:00 a.m., 7 days a week.

Area residents requested the implementation of overnight on-street permit parking on the south side of Lynn Williams Street, between Pirandello Street and East Liberty Street to accommodate their long term parking needs without being subject to tagging by Parking Enforcement.

RECOMMENDATIONS

Transportation Services recommends to Toronto and East York Community Council that:

1. Schedule A of Municipal Code Chapter 925 be amended to incorporate the south side of Lynn Williams Street, between Pirandello Street and East Liberty Street, under the operating hours of 6:00 p.m. to 7:00 a.m., 7 days a week.

Financial Impact

The estimated cost associated with the installation of new permit parking signage is estimated at \$200.00 and is within the Transportation Services Division's 2010 Operating Budget.

ISSUE BACKGROUND

A request was received from Deputy Mayor Joe Pantalone, on behalf of area residents for the introduction of overnight on-street permit parking on Lynn Williams Street, between Pirandello Street and East Liberty Street, with the operating hours of 6:00 p.m. to 7:00 a.m., 7 days a week.

COMMENTS

Lynn Williams Street, between Pirandello Street and East Liberty Street, is a local roadway operating a two-way east/westbound direction with a pavement width of 8.8 metres. There is no TTC service on Lynn Williams Street, between Pirandello Street and East Liberty Street. Parking is allowed on the south side of the street for a maximum period of three hours. Parking is prohibited at anytime on the north side of the street.

Under the provisions of the Municipal Code, Chapter 925, Permit Parking, we are required to conduct a poll of the residents to determine if there is support to introduce permit parking.

Ballots were mailed on October 29, 2009, with the last day for filing a response being November 27, 2009. The results of the poll are as follows:

A field survey has determined that there are thirty-five (35) potential on-street parking spaces available on the south side of Lynn Williams Street, between Pirandello Street and East Liberty Street.

The majority of area residents returned their ballots in favour of the introduction of overnight on-street permit parking on Lynn Williams Street, between Pirandello Street and East Liberty Street to accommodate their long term need for on-street parking.
