Re: Sidewalk/Boulevard Café Extension Application – File # B069351

I am writing in reference to your application to extend your Sidewalk/Boulevard Café privileges.

Boulevard cafes are governed by the criteria set out in Chapter 313 of the former City of Toronto Municipal Code. One of the provisions of the Code is that boulevard cafes shall provide 2.13 meters clearance from the curb and/or any street furnishings (i.e. tree planters, poles, and benches...) in order to maintain adequate pedestrian space.

A review of the proposed location has determined taking into consideration the clearance requirement described above, that there is insufficient space to operate a boulevard café at this location. Therefore, your application has been refused as applied.

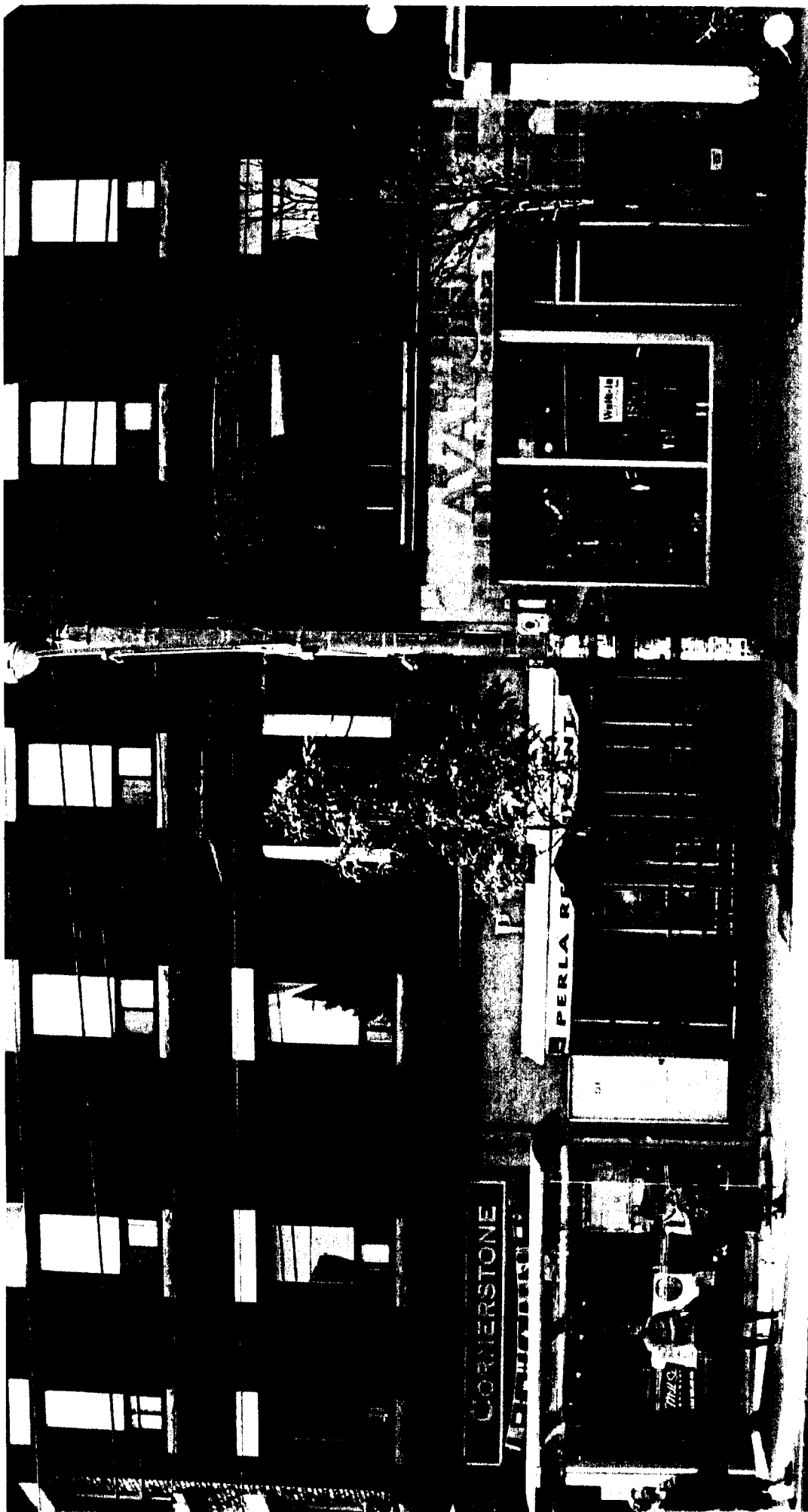

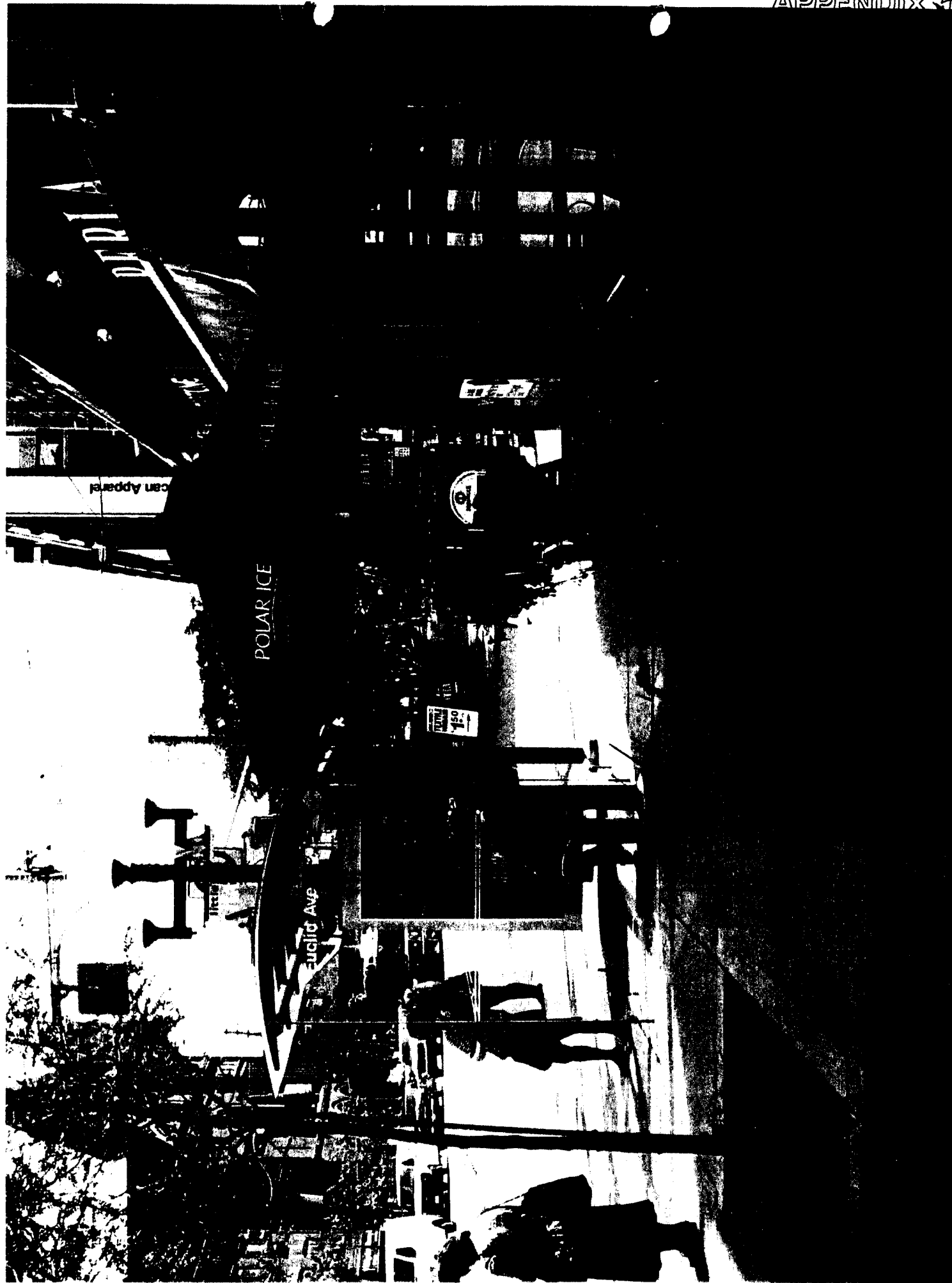
