

## **2010 Municipal Election - Candidates in Default**

### **SUMMARY**

---

The purpose of this report is to advise Council of the 2010 municipal election candidates who failed to file financial statements by the legislated deadline of 2:00 p.m. on March 25, 2011 and are subject to penalties under the *Municipal Elections Act, 1996*, as amended.

### **COMMENTS**

Subsection 80(3) of the *Municipal Elections Act, 1996*, as amended, (the *Act*) requires the Clerk to notify Council of any candidates who are in default of the *Act*.

A candidate is in default if he or she:

- fails to file the required financial statement and/or auditor's report by the relevant date;
- fails to pay to the Clerk the surplus amount shown on the face of their financial statement by the relevant date; or
- has incurred expenses exceeding what is permitted under the *Act*.

A candidate in default is ineligible to be elected or appointed to any office to which the *Act* applies until the next regular election has taken place. In addition, if a candidate is an elected official, they forfeit the office to which they were elected and the office is deemed to be vacant.

Attached is a list for Council's information of the candidates who ran for the offices of mayor or councillor and were in default as of 2:00 p.m. on March 25, 2011. These individuals will not be able to run for office until the next regular (2014) election has taken place.

As required under the *Act*, the Clerk sent notice to each candidate on March 31, 2011, advising they are in default and of the penalties involved.
