The Council of the City of Toronto proposes to pass a by-law to permanently close the east section of the untravelled Westgate Boulevard located north of Highway 401 and east of Bathurst Street, designated as Part 1 on Reference Plan 66R-25566, City of Toronto.

At its meeting to be held in the Council Chamber at the North York Civic Centre on June 22, 2011, the North York Community Council, at 10:15 a.m., will hear in person or by his or her counsel, agent or solicitor, any person who wishes to speak to this matter.
