To Consider Whether to Recommend a Repeal of the new Zoning By-law for the City of Toronto No. 1156-2010

PROPOSAL

The City of Toronto is holding a special meeting of the Planning and Growth Management Committee to hear from the public and consider whether to recommend that City Council repeal the new Zoning By-law for the City of Toronto No. 1156-2010.

BACKGROUND INFORMATION

On August 27, 2010 the City of Toronto enacted the new Zoning By-law for the City of Toronto No. 1156-2010 which regulates the use of the land, the size and location of buildings and structures, parking and loading. On April 13, 2011, the Council of the City of Toronto decided to hold a special meeting of the Planning and Growth Management Committee on May 10, 2011 to consider whether to recommend that the new Zoning By-law be repealed.

Repeal of this By-law may affect approval of building permits, zoning certificates or other applications for a minor variance, a consent to sever, an amendment to a zoning by-law, an Official Plan amendment, a Minister's zoning order or for approval of a plan of subdivision and any appeals of these applications submitted to the City prior to August 27, 2010, as well as appeals of the new Zoning By-law for the City of Toronto No. 1156-2010 currently before the Ontario Municipal Board. All land owners and applicants should review the Zoning By-law for the City of Toronto 1156-2010 carefully and consult with your professional advisors about how a repeal of this By-law may impact your lands or development applications.

1. The public meeting will be held on May 10, 2010, at 2:00 p.m. or as soon as possible thereafter, in Committee Room 1, Second Floor, City Hall, 100 Queen St. West, Toronto. - 5. A repeal of By-law-1156-2010 may affect land which is the subject of an application under the Planning Act for a minor variance or a consent to sever, for a zoning by-law amendment, for an official plan amendment or a Minister's zoning order, or for approval of a plan of subdivision.
