The Budget Committee's recommendations will be forwarded for Executive Committee's consideration at its special meeting on November 19, 2012, and to City Council at its meeting on November 27, 2012. The adopted fees will be implemented through a by-law that will amend the Municipal Code.

While the 2013 Residential Solid Waste Rate Report sets out the recommended rate, the appropriate Committee may change these recommendations and Toronto City Council may adopt rates that differ from the recommendations, including rates that are higher or lower than the rates set out above.
