#### Community Safety Investment Program – 2012 Allocation Recommendations

##### Committee Decision

The Community Partnership and Investment Program Appeals Committee recommends to the Community Development and Recreation Committee for its meeting on June 26, 2012 that:

1. City Council approve the 2012 Community Safety Investment Program (Community Safety) allocations totalling \$665,600.00 to 17 organizations as recommended in Appendices A and B of the report (May 29, 2012) from the Executive Director, Social Development, Finance and Administration.
2. City Council direct that an amount of \$31,200.00 be held for appeals.

##### Decision Advice and Other Information

The Community Partnership and Investment Program Appeals Committee met on June 11, 2012 and heard appeals to the Community Safety Investment Program - 2012 Allocation Recommendations.

### **Summary**

This report recommends allocations for funding under the 2012 Community Safety Investment Program. Of the 59 applications received 17 are recommended for funding of \$665,600.00. An amount of \$31,200.00 has been held for appeals.

The Community Safety Investment program makes resources available to organizations that are in a unique position to reach vulnerable communities with information, prevention activities and situation-specific responses that help create safer places for everyone.
