62 Minnacote Avenue – Application to Remove Two Private Trees

SUMMARY

This report requests that City Council deny the request for a permit to remove two (2) privately-owned trees. The owners have indicated they are no longer able to incur the labour and costs associated with maintaining both trees.

The subject trees are a 55 cm diameter white spruce (*Picea glauca*) located at the front of the property and a 44 cm diameter honey locust (*Gleditsia triacanthos*) in the backyard. Both trees are in fair to good condition.

RECOMMENDATIONS

The General Manager of Parks, Forestry and Recreation recommends that:

1. City Council deny the request to remove two (2) privately-owned trees at 62 Minnacote Avenue.

Financial Impact

There are no financial implications resulting from the adoption of this report.

COMMENTS

An application was received from the owner of 62 Minnacote Avenue for a permit to remove two (2) privately-owned trees located on the subject property. The tree at the front of the property is a 55 cm diameter white spruce, located approximately 5 m from the house foundation. The second tree is a 44 cm diameter honey locust, located in the backyard approximately 3.5 m from an existing solarium. The honey locust tree is of concern to the owners due to issues of maintenance of the solarium which was built close

to the tree. The property owners indicate they are no longer able to incur the labour and costs associated with maintaining the trees.

Inspection of the trees by staff revealed that both trees are in fair to good condition. The spruce was previously pruned to remove lower branches away from the house. Both trees are structurally sound with no dieback. Staff observed no evidence that either tree is hazardous.

The arborist report which was submitted by an independent arborist with the application to remove the trees stated that the trees in question are in good condition.

The property has several trees and the owners have submitted a replanting plan indicating their willingness to plant two replacement trees should approval be granted to remove the subject trees.

As required under *Section 813-17, of City of Toronto Municipal Code, Chapter 813, Trees, Article III*, a 'Notice' of application sign was posted on the subject property for the minimum 14 day posting period in order to notify the community of the application and provide an opportunity for objection. One letter of objection was received in response to this application to remove the two trees in question.

Issuance of a permit to remove the trees was refused, as Urban Forestry does not support removal of healthy trees for the stated reasons. The owner has appealed the decision to refuse a permit for removal of the 55 cm diameter white spruce and the 44 cm diameter honey locust.

These trees are significant and a valuable part of the forest community that exists within this area. With proper care and maintenance, the subject trees should continue to provide benefits to the property owner and the surrounding community for many years to come. Urban Forestry cannot support removal of these trees.
