Parking Amendment – Rostrevor Road

SUMMARY

This staff report is about a matter that Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting authority to adjust the "No Parking", 8:00 a.m. to 10:00 a.m. and 4:00 p.m. to 6:00 p.m., Monday to Saturday" regulation, on the west side of Rostrevor Road, from Dewbourne Avenue to a point 44 metres south of Eglinton Avenue West, so that it is in effect from Monday to Friday, only.

RECOMMENDATIONS

Transportation Services recommends that Toronto and East York Community Council:

- 1. Rescind the "No Parking 8:00 a.m. to 10:00 a.m. and 4:00 p.m. to 6:00 p.m., Monday to Saturday" regulation, on the west side of Rostrevor Road, from Dewbourne Avenue to a point 44 metres south of Eglinton Avenue West.
- 2. Approve implementation of a "No Parking 8:00 a.m. to 10:00 a.m., and 4:00 p.m. to 6:00 p.m., Monday to Friday" regulation on the west side of Rostrevor Road, from Dewbourne Avenue to a point 44 metres south of Eglinton Avenue West.

Financial Impact

Funding for the necessary signage adjustments in the estimated amount of \$100.00 are available within Transportation Services Division 2012 Interim Operating Budget.

ISSUE BACKGROUND

Councillor Joe Mihevc, on behalf of area residents, requested Transportation Services to adjust the "No Parking 8:00 a.m. to 10:00 a.m. and 4:00 p.m. to 6:00 p.m., Monday to Saturday"

regulation that is currently in effect on the west side of Rostrevor Road from Dewbourne Avenue to a point 44 metres south of Eglinton Avenue West, to operate from Monday to Friday, only.

COMMENTS

Rostrevor Road is a local roadway that operates one-way southbound, between Eglinton Avenue West and Dewbourne Avenue. The posted speed limit is 30 km/h, in connection with the traffic calming that is installed on this street. There is no TTC service on this section of Rostrevor Road.

The following parking regulations are in effect on Rostrevor Road, between Dewbourne Avenue and Eglinton Avenue West:

West side:

- No parking at anytime from Eglinton Avenue West to a point 44 metres south of Eglinton Avenue West;
- No parking from 8:00 a.m. to 10:00 a.m. and from 4:00 p.m. to 6:00 p.m., Monday to Saturday from Dewbourne Avenue to a point 44 metres south of Eglinton Avenue West; and
- At other times, parking is permitted for maximum period of three hours.

East side:

• No parking at anytime.

Residents of Rostrevor Road met with Councillor Mihevc to request support for the change of the parking prohibition that is currently in effect on the west side of Rostrevor Road, between Dewbourne Avenue and a point 44 metres south of Eglinton Avenue West.

Transportation Services has no objections to amending this parking regulation as requested by the local area residents.
