Description:	Contract No. 13SE-20S for The Gardiner Expressway Median Replacement from Ellis Avenue to Dufferin Street in the City of Toronto. Work includes Traffic control and signing, removal of existing steel beam guiderail and replacement with precast tall wall barrier, poured in place concrete barrier wall, and modifications to existing catchbasins.

Contract Award Value:	\$5,127,579.00 net of all applicable taxes and charges \$5,794,164.27 including all applicable taxes and charges \$5,217,824.39 net of HST recoveries  Contract is expected to start on January 10, 2014 and end on July 31, 2014.

  - ii. for a contract funded by the capital budget, within the projected term of the capital funding for the project as set out in the capital budget, being within the authority of the Bid Committee;
- (d) There are no material written objections to the award;
- (e) The call document was advertised on the City's internet website and bids or proposals were opened publicly; and
- (f) The Fair Wage Office confirms the recommended firm understands the Fair Wage Policy and Labour Trades requirements and has agreed to comply fully.
