Toronto Parking Authority - 2014 Recommended Operating Budget, and the 2014 Recommended Capital Budget and 2015 - 2023 Recommended Capital Plan

2014 Toronto Parking Authority Rates Toronto Municipal Code, Chapter 441, Fees and Charges

The Budget Committee of Toronto City Council will be considering Toronto Parking Authority – 2014 Recommended Operating Budget, and the 2014 Recommended Capital Budget and 2015 - 2023 Recommended Capital Plan at its meetings on November 1, 2013, November 6, 2013 and November 12, 2013.

Notice is hereby given that City officials are recommending that the maximum hourly on-street parking rate as outlined in City of Toronto Municipal Code Chapter 441, Fees and Charges, Appendix G - Schedule 1, Toronto Parking Authority, remain unchanged.

The Budget Committee of Toronto City Council will receive presentations from any person, or their counsel, agent or solicitor, who wishes to speak to the matter, on Wednesday, November 6, 2013, at 9:30 a.m. or as soon as possible thereafter, in Committee Room 1, Second floor, City Hall, 100 Queen Street West, Toronto.

There will be a 5 minute time limit for each presentation, unless the Committee decides otherwise.

Any comments received after the Budget Committee meeting will be processed to Council.

The Budget Committee's recommendations will be forwarded for Executive Committee's consideration at its meeting on December 5, 2013, and to City Council at its meeting on December 16 and 17, 2013. The adopted fees will be implemented through a by-law that will amend the Municipal Code, if necessary.

While the 2014 Toronto Parking Authority Operating Budget does not recommend any rate change, the appropriate Committee may change these recommendations and Toronto City Council may adopt rates that differ from the recommendations, including rates that are higher or lower.
