**DECISION HISTORY**

City of Toronto Municipal Code Chapter 103, Heritage, sets out the composition and nomination process for the City’s Community Preservation Panels. The Etobicoke York Community Council is to nominate one to three Members to the Community Preservation Panel for the Community Council area.

Council appointed Members in May 2011 for a term of office ending December 31, 2012 and until successors are appointed. It is now necessary to appoint Members for the second half of the Council term.
