SUMMARY

The purpose of this report is to obtain approval for the introduction of a "No Standing" prohibition from 6:00 p.m. to 7:00 a.m., daily, on the east side of Weston Road, north of Sidney Belsey Crescent.

Since the Toronto Transit Commission (TTC) provides service on Weston Road, City Council approval of this report is required.

RECOMMENDATIONS

Transportation Services recommends that City Council approve:

1. Enacting a standing prohibition from 6:00 p.m. to 7:00 a.m., daily on the east side of Weston Road, between a point 30.5 metres north of Sidney Belsey Crescent and a point 100 metres further north.

ISSUE BACKGROUND

The Ward Councillor, on behalf of the residents of Weston Road, requested Transportation Services Division staff to assess the feasibility of introducing a "No Standing" from 6:00 p.m. to 7:00 a.m., daily regulation on the east side of Weston Road north of Sidney Belsey Crescent. This prohibition will eliminate heavy trucks and tractor trailers from parking overnight on the east side of Weston Road. A map of the area is Attachment 1.

COMMENTS

Weston Road, in the vicinity of Sidney Belsey Crescent, is a minor arterial roadway, which operates two-way with a posted speed limit of 50 km/h and a pavement width of 18 metres. Permit parking is not in effect and parking is otherwise allowed for a maximum period of three hours, on the east side of Weston Road in the vicinity of 1551 Weston Road. The TTC operates a transit service on Weston Road.

Transportation Services staff has determined that it is feasible to introduce the "No Standing" prohibition between the hours of 6:00 p.m. to 7:00 a.m., daily. The intention is to emphasize that this area is strictly prohibited for heavy trucks to park overnight.
