SUMMARY

This staff report is about a matter that Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to enable longer term parking by vehicles of persons visiting Union Street, by rescinding the existing one hour maximum parking restriction from 8:00 a.m. to 6:00 p.m., daily. This recommendation has been discussed with the area Councillor.

RECOMMENDATIONS

Transportation Services recommends that Etobicoke York Community Council approve:

1. Rescinding the one hour maximum parking restriction from 8:00 a.m. to 6:00 p.m., on the east side of Union Street, between a point 9 metres south of Turnberry Avenue and a point 211 metres further south.

ISSUE BACKGROUND

As a result of concerns and requests from a business on Union Street and the area Councillor, Transportation Services staff investigated the feasibility of rescinding the one hour maximum parking restriction that applies from 8:00 a.m. to 6:00 p.m., on the east side of Union Street to enable longer term parking by motorists visiting businesses on the street.

COMMENTS

Union Street, between Turnberry Avenue and Townsley Street operates two-way with a pavement width of 8.5 metres and a speed limit of 50 kilometres per hour.

Stopping is prohibited at all times on the east side of Union Street, between Townsley Street and a point 220 metres south of Turnberry Avenue. Parking is prohibited at all times on the west side of Union Street, between Townsley Street and Turnberry Avenue. Parking is currently allowed for a maximum period of one hour from 8:00 a.m. to 6:00 p.m., daily, on the east side of Union Street from a point 9 metres south of Turnberry Avenue to a point 211 metres further south. Parking is otherwise permitted for a maximum period of three hours at other times.

Rescinding the one hour maximum parking will, by default, enact the City-wide 3-hour maximum parking restriction. This will allow trades people and visitors of the area businesses to park for a period of time up to three hours instead of the current one hour maximum.
