SUMMARY

This staff report is about a matter that Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to obtain approval to amend the existing "No Parking Anytime" and "No Standing Anytime" regulations on Geary Avenue, between Dufferin Street and the west limit of the road.

RECOMMENDATIONS

Transportation Services recommends that Etobicoke York Community Council:

1. Approve the amendments to parking regulations on Geary Avenue, as outlined in Appendix "A" and Appendix "B" attached to the report dated October 23, 2013 from the Director, Transportation Services - Etobicoke York District.

ISSUE BACKGROUND

The Ward 17 Councillor received a complaint from Textile Manufacturing Company Limited, located at 1384 Dufferin Street, that due to the existing "No Standing Anytime" regulation they were unable to load and unload goods to their loading dock that fronts Geary Avenue. Transportation Services staff investigated the concern and suggest amending the by-law from "No Standing Anytime" to "No Parking Anytime" from Dufferin Street to a point 38 metres further west, to allow loading and unloading of goods to their loading dock. A map of the area is Attachment 1.

COMMENTS

Geary Avenue is a 7.3 metres wide two-way local road located west of Dufferin Street, north of Dupont Street. The posted speed limit on the street is 40 km/h. Sidewalks exist on the north side of Geary Avenue from Dufferin Street to the west limit of the road.

After our review and meeting with the area Councillor and the owner of Textile Manufacturing Company Limited, Transportation Services staff can support an amendment of the existing "No Standing Anytime" regulation and change it to a "No Parking Anytime" regulation on the north side of Geary Avenue from Dufferin Street to a point 38 metres further west. We will also amend the "No Parking Anytime" regulation on the south side of Geary Avenue to a "No Standing Anytime" regulation from Dufferin Street to a point 44 metres further west.

The existing parking regulations on Geary Avenue that are to be replaced are outlined in the attached Appendix "A". The regulations to be enacted are set out in the attached Appendix "B".

The recommendations to amend the existing regulation on Geary Avenue will provide an area for Textile Manufacturing Company Limited to access their loading dock for the purpose of loading and unloading goods.
