Installation of On-Street Accessible Parking Space: Glengrove Avenue West

SUMMARY

This staff report is about a matter that Community Council has delegated authority to make a final decision, provided that it is not amended so that it varies with City policy or by-laws.

To obtain approval to install an on-street accessible parking space on the south side of Glengrove Avenue West.

The installation of an on-street accessible parking space will address the needs of the resident of 149 Glengrove Avenue West, while only reducing the available on-street parking by one space.

RECOMMENDATIONS

Transportation Services, North York District, recommends that North York Community Council:

1. Approve the installation of one on-street accessible parking space on the south side of Glengrove Avenue West, from a point 34 metres east of Rosewell Avenue to a point 5.5 metres further east.

Financial Impact

All costs associated with the installation of a designated Accessible On-Street Parking Space are included in Transportation Services 2013 Operating Budget.

ISSUE BACKGROUND

Transportation Services, North York District, received a request from the resident of 149 Glengrove Avenue West, to investigate the feasibility of installing an on-street accessible parking space on the south side of Glengrove Avenue West, adjacent to 149 Glengrove Avenue West.

COMMENTS

Glengrove Avenue West is a local roadway with a pavement width of approximately 8.5 metres with sidewalks on both sides of the road. Currently, parking is permitted for a maximum period of three hours at this location.

The applicant is a holder of a valid “Accessible Parking Permit” issued by the Ministry of Transportation of Ontario.

The requested location of the on-street accessible parking space would be on the south side of Glengrove Avenue West located 34 metres east of Rosewell Avenue to a point 5.5 metres further east. This designated parking space would be adjacent to 149 Glengrove Avenue West. The installation of an on-street accessible parking space will not have a negative impact on the flow of traffic on Glengrove Avenue West.

As such, this Division supports the installation of the designated on-street accessible parking space.

The Ward Councillor has been advised of the recommendation contained in this staff report.
