SUMMARY

This staff report is about a matter for which the Community Council has delegated authority from City Council to make a final decision.

This staff report concerns the feasibility of installing 30-minute permitted parking regulations from 8:00 a.m. to 4:00 p.m., Monday to Friday, on the north side of Ingleton Boulevard, in the vicinity of Macklin Public School.

The proposed parking regulations will accommodate a pick-up and drop-off area for students and reduce parking related congestion in front of the school.

RECOMMENDATIONS

Transportation Services recommends that Scarborough Community Council:

- 1. Rescind the stopping and school bus loading zone regulations, as identified in Appendix 1 of this report.
- 2. Enact the parking and school bus loading zone regulations, as identified in Appendix 2 of this report.
- 3. Pass or amend the appropriate by-laws(s) accordingly.

Financial Impact

The financial cost of installing the subject recommended parking signs is approximately \$1000.00. The funding for the signs is available in the Transportation Services 2013 Operating Budget, within Cost Centre TP0397.

ISSUE BACKGROUND

As a result of a request from Councillor Chin Lee on behalf of representatives from Macklin Public School located on Ingleton Boulevard, Transportation Services staff reviewed the parking issues on Ingleton Boulevard between Presidents Court and Shady Hollow Drive to determine the feasibility of accommodating short term parking in the vicinity of the school.

The current parking regulations on Ingleton Boulevard between Presidents Court and Shady Hollow Drive are as follows:

- No Stopping, 7:00 a.m. to 6:00 p.m., Monday to Friday on the north side, between a point 31 metres west of Shady Hollow Drive and a point 112 metres further west.
- A school bus loading zone is located on the north side between a point 102 metres east of Presidents Court and a point 61 metres further east.
- No Stopping, 7:00 a.m. to 6:00 p.m., Monday to Friday on the south side between a point 60 metres west of Shady Hollow Drive and a point 45 metres further west.

Transportation Services staff conducted a school zone review during the morning, mid-day and afternoon arrival and dismissal times. An examination of motorist parking/stopping patterns confirmed that the majority of motorists parked/stopped illegally in the signed area on the north/school side of Ingleton Boulevard and in the signed school bus loading zone to pick-up and drop-off students. Motorists also parked on the south/opposite side of Ingleton Boulevard. The parked/stopped vehicles on both sides of the road restricted two-way traffic flow and obstructed the view of pedestrians crossing the road at midblock locations from between parked cars.

COMMENTS

The following characteristics describe Ingleton Boulevard:

- Ingleton Boulevard is located north of McNicoll Avenue and east of McCowan Road.
- Ingleton Boulevard is a two-lane collector road with a width of approximately 8.5 metres.
- The land uses on Ingleton Boulevard consist of single family residential dwellings and schools.
- Sidewalks are located on both sides of Ingleton Boulevard between Presidents Court and Shady Hollow Drive.
- The proposed "30 Minutes Permitted Parking, 8:00 a.m. to 4:00 p.m., Monday to Friday" zones on the north side of Ingleton Boulevard will permit short term parking for parents to pick-up and drop-off students to and from the school.
- The proposed "No Stopping, 8:00 a.m. to 4:00 p.m., Monday to Friday" zones will enhance sightlines and maintain two-way traffic flow near the school.

We anticipate that the proposed "30-Minute Permitted Parking, 8:00 a.m. to 4:00 p.m., Monday to Friday" zones will accommodate a pick-up and drop-off area for students that can be enforced. The proposed parking regulations will also enhance sightlines, reduce congestion, and maintain two-way traffic flow in the area.
