Compensation Benchmark Report Elected Officials

Introduction

This report summarizes the results of a customized compensation survey sponsored by the City of Toronto in February of 2014. Previous studies were conducted in 2010 and 2006.

For consistency, the same sixteen (16) comparator organizations used in 2010 were invited to participate in the 2014 survey. Data was received from all of the invited municipalities, making up the following comparator group:

The comparator group is a mix of single tier and regional governments in the local and national level. The City of Toronto and some of the comparators (Winnipeg, Calgary etc.) represent a combination of both lower and upper tier municipalities. The main difference from these comparators is in terms of scale and scope. There may be nuances in the benefits and pensions (some slightly different) however the focus was on the cash components of compensation. Where councillor salaries differed, we used maximums for the position in their elected office and then added on depending on their additional responsibilities. Compensation from all sources were considered in the analysis of elected official remuneration, including the following elements:

- Base Salary (local and regional): The salary paid by a municipality.
- **Tax-Free Portions of Salary:** Where a portion of the salary paid is non-taxable, the dollar value of the salary was grossed up to reflect the fully taxable value of the amount paid. The highest provincial marginal tax rate was used in these calculations 49.53% in Ontario and 39.00% in Alberta.
- **Compensation for Additional Responsibilities:** Any amounts paid for activities such as chairing committees, or being a board member of a city-owned agency, board or utility.
- Other Cash Compensation: Other elements of compensation not requiring reimbursement invoices such as car allowances.

Background

- At its meeting on July 25, 26 and 27, 2006 City Council discussed the report titled "Compensation Review: Elected Officials" and approved that:
 - the salary level of Councillors and the Mayor be set at the greater of their current compensation or at the 75th percentile of the comparator market group as at January 1st of each new term.
 - A study be done prior to the beginning of each term to determine the compensation of City Councillors and the Mayor in an appropriate comparator group defined by a specialist consultant.

- A 2014 market survey of elected officials' compensation is required pursuant to Council's direction from 2006 that "a study be done prior to the beginning of each term to determine the compensation of City Councillors and the Mayor in an appropriate comparator group defined by a special Successful Proponent."

Methodology

- In 2014, OCG invited the same comparator group used in 2010. A survey questionnaire (Appendix A) was sent to the comparator group. All municipalities and regions responded to the survey.
- All municipalities were asked to provide salary information for the positions of Councillor and Mayor, including: base salary, tax free compensation portions, any payments from agencies / boards / commissions, and other forms of cash compensation.
- Questions regarding annual operating budgets, current population and number of Councillors forming the municipal council, as well as demographic information were also asked to provide context.
- The current established City of Toronto policy is to pay the greater of actual base salary or the 75th percentile (P75) total cash of the comparator market.

Note 3: Expense allowance of \$15,787 and additional remuneration for positions held, up to maximum allowed.

Note 4: Varies depending on appointment - Metro Vancouver Vice Chair \$35,468 per year, Committee and Board members also paid per meeting \$355 for up to 4 hours and \$710 maximum per full day meeting. In 2013 Vancouver City Councillors received amounts ranging from \$692 to \$41,950 from the regional government. In addition, There is annual local expense Budget of up to 10% of remuneration (\$6,799). Councillor can opt to receive a transportation allowance of \$4,213 reducing the budget for local expenses to \$2,720.

- The City of Toronto is the largest in terms of operating budget, population and size of council. The large council puts the city at the 74th percentile in terms of residents per councilor.
- Relative to total salary including both local and regional salaries, City of Toronto Councillor salaries are 11% below the 75th percentile and 5% above the 50th percentile (median) of the comparator group, placing the City of Toronto at just over the median, or 55th percentile of the group.
- The overall total cash compensation falls to 5% below the median and 11% below the 75th percentile when all sources
 of income including additional remuneration for additional responsibilities are taken into account, dropping the City of
 Toronto Councillor salary to the 37th percentile of the group's total cash.
- In 2010, the salary for City of Toronto Councillors was at the 83rd percentile of the same comparator group's total salary and at the 77.5th percentile of the group's total cash. In comparison, Councillor salaries are farther below the 75th percentile than they were in 2010.
 - Some of this may be explained by differences in survey reporting and methodology. In 2014, the cities of Montreal and Vancouver reported Councillor income received from regional sources, while no regional income was declared in the 2010 report.

- The City of Toronto is the largest in terms of operating budget, population and size of council.
- Relative to total salary which includes regional salaries in addition to lower tier mayoral salaries, the City of Toronto's mayoral salary is 8% below the 75th percentile and 4% above the 50th percentile (median) of the comparator group, placing the City of Toronto at the 61th percentile of the group.
- The overall total cash compensation falls to 11% below the 75th percentile and 4% above the median when all sources of income including additional remuneration for additional responsibilities are taken into account, still placing the City of Toronto at the 61st percentile of the group.
- In 2010, the salary for the Mayor of Toronto was at the 52.5nd percentile of the same comparator group's total salary and at the 46th percentile of the group's total cash. In comparison, the Mayor salary is now at the 61st percentile.

Conclusions

- The City of Toronto's approved policy for elected officials' compensation is to pay at the 75th percentile of its comparator market.
- The current Mayor salary is at the 61st percentile, when total cash is considered.
- The current Councillor salary is at the 37th percentile, when total cash is considered.
- The City's current policy of an annual CPI adjustment has not kept pace with the comparator market adjustments. This is in line with what the Hay Group identified in 2010. It is critical that an appropriate mechanism be in place that provides for annual adjustments to ensure competitive market positioning is maintained.
- Usually in conducting this type of survey work, the data and analysis reflects the information at the time of collection. Any adjustments to the compensation of elected officials in any of the 16 municipalities subsequent to the data collection time point would impact on the percentile levels.
