ISSUE BACKGROUND

This matter concerns unpaid property taxes at the property municipally known as 3500 Eglinton Avenue West. It is currently owned by Metrolinx, and is to be used as a rail storage yard for the Eglinton Crosstown line.

The unpaid property taxes relate to a period of time in which the property was owned by the previous owner, Zeehan Capital Inc. The property taxes were largely balanced as of the date of sale on January 25, 2012, however, the taxes were retroactively increased as a result of an assessment appeal commenced by the City of the current value of the property for the 2007 and 2008 taxation years.

COMMENTS

Lawyers for the City prepared a Statement of Claim which was issued in the Ontario Superior Court on April 4, 2014. The proceeding goes by the style of cause and court file number Toronto (City) v. Zeehan Capital Inc., court file number CV - 14 - 501521.

Zeehan Capital Inc. was noted in default on May 2, 2014 for failure to submit a Statement of Defence.
