PROPOSAL

This Zoning By-law Amendment application proposes the construction of two mixed-use base buildings with three residential towers at heights of 39, 33, and 24 storeys, comprised of 1017 residential units and approximately 9,500.00 square metres of non-residential floorspace at 11 and 25 Ordnance Street and 45 Strachan Avenue. A new public park is proposed on the lands at 10 Ordnance Street. This application also proposes amendments to Zoning By-law 159-2012 which is subject to the two previously approved residential buildings situated at 30 Ordnance Street (10 115786 STE 19 OZ).

Zoning By-law Amendments Appeal: If a person or public body does not make oral submissions at a public meeting or make written submissions to the City Clerk, attention: Nancy Martins, Administrator, Planning and Growth Management Committee, at the address set out in this notice or by Fax: 416-392-1879 before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision to the Ontario Municipal Board and may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.
