**PROPOSAL**

The application to amend the Zoning By-law would enable the development of a portion of the vacant site known as 2201 Markham Road, with a 1,481 square metre (15,941 square foot), 2-storey vehicle dealership featuring vehicle service facilities, offices and a showroom and sales area.

In September 2013, the Committee of Adjustment approved an application for consent to sever a portion of 2201 Markham Road to create a new 7,084 square metre (76,251 square foot) lot with 53.92 metres (177 feet) of frontage on Markham Road for a proposed medical/dental office. The Lot Division Plan included with the application showed the conveyed lot for the medical/dental office, a shared private driveway, and the draft boundaries for three other new parcels within the boundaries of the retained lot. The applicant has since submitted a consent application to formally sever another portion of 2201 Markham Road for the proposed vehicle dealership (Application No. B009/14SC).


## FURTHER INFORMATION

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City Clerk, attention: Yvonne Davies, Administrator, Scarborough Community Council, at the address set out in this notice or by Fax: 416-396-4301 before the proposed Zoning By-law Amendment is passed or refused the person or public body is not entitled to appeal the decision to the Ontario Municipal Board and may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.
