

Appendix A

Recommended 2015 Solid Waste Rates

This Appendix illustrates various aspects of the Public Notice hereby given. City officials are recommending that the City Council of the City of Toronto pass a by-law to increase current Solid Waste Rates and Fees, introduce new Solid Waste Rates and Fees, and change the City's Single Family Residential Rebates for waste bins, all effective April 1, 2015:

1. Examples of Key Solid Waste Rates and Fees proposed to increase by 3%

As stated in the Public Notice, City officials are recommending a 3% increase to all current Solid Waste Rates and Fees set forth in Schedule 1 of Appendix A to Chapter 441 of the Toronto Municipal Code (the "Schedule"). Below are examples of several key Solid Waste Rates and Fees from the Schedule with the 3% increase applied. Please note that the remaining rates and fees found on the Schedule, but not listed below, also have been recommended to increase by 3%.
