SUMMARY

The purpose of this report is to recommend the appointment of Members of Council to business improvement area boards.

RECOMMENDATIONS

The City Clerk recommends that:

1. City Council appoint the following Ward Councillors to business improvement area boards for a term of office until November 30, 2018 and until successors are appointed:

a. Councillor Mike Layton, Ward 19, Trinity-Spadina to the Ossington Business Improvement Area Board;

b. Councillor Josh Matlow, Ward 22, St. Pauls and Councillor Joe Mihevc, Ward 21, St. Pauls, to The Dupont by the Castle Business Improvement Area Board;

c. Councillor Josh Matlow, Ward 22, St. Pauls, to the Rosedale Main Street Business Improvement Area Board; and

d. Councillor Pam McConnell, Ward 28, Toronto Centre-Rosedale, to the Toronto Entertainment District Business Improvement Area Board.

COMMENTS

There have been changes to Business Improvement Areas

The Ossington Business Improvement Area is a new BIA located in Ward 19, Trinity-Spadina.

The Dupont by the Castle Business Improvement Area Board now includes the Councillors for Wards 21 and 22, St. Pauls. The Councillor for Ward 20, Trinity-Spadina is already appointed.

The Rosedale Mainstreet Business Improvement Area Board now includes the Councillor for Ward 22, St. Pauls. The Councillor for Ward 27, Toronto Centre-Rosedale is already appointed.

The Toronto Entertainment District Business Improvement Area Board now includes the Councillor for Ward 28, Toronto Centre-Rosedale. The Councillor for Ward 20, Trinity-Spadina is already appointed.

Additional appointments are required

As a result of the establishment of a new BIA and changes to three other BIA boards, additional Council Member appointments are required. The Ward Councillors are appointed to these community-based boards.
