# **Business Improvement Area Boards of Management -** 2015 - 2018 Appointments

#### **SUMMARY**

The purpose of this report is to recommend Etobicoke York Community Council appoint members to the Boards of Management for the new term of Council for twelve (12) Business Improvement Areas that fall within the Etobicoke York Community Council boundaries. The Etobicoke York Community Council has delegated authority to make final decisions regarding BIA appointments.

## **RECOMMENDATIONS**

# The Director, Business Growth Services, Economic Development and Culture, recommends that:

- 1. Etobicoke York Community Council appoint the nominees listed in Attachment No. 1 to the Boards of Management for twelve (12) Business Improvement Areas (BIAs) for a term expiring at the end of the term of Council or as soon thereafter as successors are appointed.
- 2. Etobicoke York Community Council confirm that under Council's Public Appointments Policy, these Board members are appointed at the pleasure of Community Council, and Community Council retains the right to replace any appointed member at any time and for any reason; and
- 3. Etobicoke York Community Council direct that Schedule A of the Municipal Code Chapter 19, Business Improvement Areas, be amended to reflect the changes in the number of members, and the number of members required for quorum of each of the BIA Boards of Management.

#### **Financial Impact**

There are no financial implications resulting from the adoption of this report.

#### **DECISION HISTORY**

Municipal Code Chapter 19 states that the term of BIA Board of Management appointments expire with the term of Council. In an election year, BIAs are required to elect nominees for appointment to the next Board of Management at an Annual General Meeting (AGM).

As of the date of this report, twelve (12) BIAs within the Etobicoke York Community Council area have held Annual General Meetings (AGMs) and elected Boards of Management for the 2015-2018 Council term. Etobicoke York Community Council has authority to appoint these nominees.

The nominees listed in Attachment No. 1 meet the requirements for membership of a BIA Board as set out in Chapter 19 of the Municipal Code.

In some cases, BIAs voted to alter the size of their Board of Management and/or quorum. Amendments are required to Schedule A of Municipal Code Chapter 19, which prescribes the number of members of each BIA Board of Management and number of members required for quorum.

#### **ISSUE BACKGROUND**

There are seventeen (17) BIAs within the geographic area of the Etobicoke York Community Council. To-date, twelve (12) have held their 2014 Annual General Meetings (AGMs) to elect members to their Boards of Management. City staff attended each AGM to ensure elections were held in accordance with the Municipal Code. Attachment No. 1 lists the Board of Management nominees, number of Councillors, and the number of members required for quorum.

The remaining five (5) BIAs will have elected their new Boards of Management by the end of January.

Council members are appointed to BIA Boards by the Striking Committee.

#### **COMMENTS**

In accordance with Municipal Code Chapter 19, the twelve (12) Business Improvement Areas located within the Etobicoke York Community Council area have elected Board of Management nominees at an Annual General Meeting. It is recommended that Council appoint the Board of Management nominees listed in Attachment No. 1 and approve any amendments required to Schedule A of Municipal Code Chapter 19 concerning the number of members of each Board of Management, and quorum.

**BIA Board Nominations** 

The nominations to five (5) BIAs in the Etobicoke York Community Council boundaries that did not hold their AGMs in sufficient time to be included in this report will be addressed in subsequent reports.
