1.North York Heritage Context

a. What make up the cultural heritage landscapes of North York?

- Pre-Settlement
- Agricultural/ Railways/Industrial/Military related Settlement
- Early Planning/Development (e.g. Lawrence Park garden suburb, Leaside model town plan)
- "Modern" suburban development
 - Planned "complete" communities e.g. Don Mills, Flemingdon Park, Thorncliffe Park
- Recent and Contemporary Development
 - Centres
 - Yonge Eglinton, North York Centre
 - o Avenues
 - Yonge, Sheppard, Eglinton etc.
 - Neighbourhoods
 - Demolition and Infill development
 - Conversion of edges of industrial parks to highway commercial

b.What are the threats to North York heritage?

 Rapid pace of development in North York district – closely behind Toronto and East York District

- City Planning is key to Heritage. Almost all development in North York is infill which means demolition of earlier cultural landscapes. Therefore Heritage needs to be a partner on all land use developments
- The City's Inventory of Heritage Properties increasingly lags behind the pace of development.
- City should consider requiring heritage impact assessments as part of development applications (per San Francisco) even where no listed buildings involved (e.g. 25 Ballyconnor)

2.North York Community Preservation Panel: how it contributes (1)

- Currently 12 members including Councillor Augimeri
- Recommends properties which should be considered by the TPB for inclusion on the Inventory
- Monitors heritage properties including those at risk, for review by the Board
 - Monitor local news media and North York Community Council
 - Track NYCPP interventions
- Researches properties for inclusion on the Inventory, public programs and other preservation related issues
- Provides for public awareness, and promotion of issues in cooperation with Heritage Toronto (HT) and other heritage groups
 - Plans and manages special events and publications i.e.
 - "North York Modernist Architecture Forums", 2010, 2011, 2012
 - North York Modernist publications in partnership with ERA Architects, 2010, 2011
 - "50 years of Medical Progress Dr Fitzgerald and Connaught Labs in North York", Nov. 13, 2014 in partnership with North York Historical Society

NYCPP: what it is and how it contributes (2)

- Promote neighborhood heritage and history
 - Participates in public consultation/engagement e.g. Eglinton Connects, Downsview Park
 - Supports local heritage events, e.g. Leaside 100
 - Promotes events like Jane's Walks, Doors Open
- Provide for activities to recognise citizen efforts re heritage protection or promotion
 - Nominations for Heritage Toronto community awards
- Coordinate with local museums, societies, TDSB etc.
- Advocate, in cooperation with HT and others as required
 - Write letters/depute to NYCC on heritage issues of concern
- Researches and recommends historical names for streets further to requests from Engineering and Construction Services and others.
- Other
 - Continuing education of members
 - Maintain linkages with heritage organizations like CCO, ACO

3. Lessons Learned

- Use all avenues available to us -
 - Active nomination process
 - Policy role letters, deputations to committees and planning projects
 - Education workshops, walks
 - City-wide role through chair's membership on TPB
- Where can limited resources best be directed? e.g. shift focus to heritage conservation districts rather than individual properties
- Collaborate/partner with others e.g. Historical Societies, Resident Associations in advocacy and special events
- Need for regular collaborative meetings with HPS and/or TPB
- Specific concerns:
 - Information on demolitions is no longer provided to Panels
 - Street naming descendant tracing/support requirements
