2016 CAPITAL BUDGET BRIEFING NOTE Skateboard Park Facilities and State-of-Good-Repair

This note responds to Budget Committee motion 16.1 #9, adopted January 11, 2015 requesting a briefing note on how much capital has been allocated to Skateboard Park state-of-good-repair and new facilities, as requested by Council in two previous budgets.

Issue/Background

Since 2000, eight permanent and three non-permanent/portable skateparks were funded through the Council-approved PFR Capital Budget and installed at a total cost of \$4.668 million. Additionally, one permanent skateboard park was completed in 2012 by Waterfront Toronto. The current 2016-2025 Preliminary Capital Plan for PFR does not include any new investments in skateboard facilities.

PFR's Facilities Master Plan, anticipated to be completed for review by the Parks & Environment Committee and Community Development and Recreation Committee in late 2016, will include guidance on the future development of skateparks in Toronto and its direction will ultimately influence subsequent PFR Capital Plans

STATE OF GOOD REPAIR

- Skateboard facilities have only been operational since 2000 and given the short period of time, have not been included as part of the state of good repair condition survey cycle until 2015.
- In fall 2015, nine permanent and eight non-permanent/portable skateboard areas were assessed. The condition assessments are currently being analyzed. Following the results of the condition surveys, capital repairs identified will be prioritized and placed in the state of good repair (SOGR) program.
- Minor general maintenance and repairs will continue to be managed by Parks Operations. Over the past two years, minor repairs at various skateparks, including repairs to concrete, fencing, signage, and granite slabs, have amounted to less than \$25,000.
