Dear Councillor Kelly and Members of the Executive Committee:

The Hurlburt family is the owner of the neighbourhood plaza at 1575-1601 Ellesmere Avenue. This plaza is located on the south side of Ellesmere, West of McCowan Road. A photograph of the plaza is attached to this letter.

This plaza has been owned and managed by the Hurlburt family since 1961. It has 15 tenants, as shown on the tenant list which is also attached. Some of these tenants have been a part of this plaza for many, many years. They have all invested significant time, energy and money to establish themselves in this location. All serve the local community.

If the McCowan route is selected for the SSE, be it the express option or not, the plaza will be considered as one of the potential sites for the TTC's terminal construction staging area. At present, the other potential sites are next door or immediately across the street from the plaza.

The plaza will, under any of the scenarios presently being considered, either be taken in its entirety, or be seriously affected, perhaps for years. The impacts of this on our family will be severe. The impacts on our tenants will be devastating.

We appreciate that these kinds of "details" are not before you at this stage of the process. We also appreciate that there will be other opportunities for us to continue the discussions that we have started with the TTC and hope to have with Councillor De Baeremaeker. However, we wanted you to be aware at this stage of the process that the selection of this brand new corridor
