SUMMARY

This staff report is about a matter for which Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to obtain approval for the removal of the existing "No Parking, Anytime" regulation on the east side of Old Burnhamthorpe Road between Indianola Drive and Embers Drive. This proposed parking regulation amendment will provide additional parking spaces for area residents.

RECOMMENDATIONS

Transportation Services recommends that Etobicoke York Community Council:

1. Rescind the parking regulation in effect at all times on the north side of Old Burnhamthorpe Road between Burnhamthorpe Road (most easterly intersection) and Burnhamthorpe Road (west intersection.)
2. Prohibit parking at all times on the north side of Old Burnhamthorpe Road between Burnhamthorpe Road (west intersection) and Embers Drive.
3. Prohibit parking at all times on the east side of Old Burnhamthorpe Road between Indianola Drive and Burnhamthorpe Road (most easterly intersection.)

Financial Impact

The estimated cost for amending the signs is \$300.00. These funds are included within the Transportation Services 2016 Operating Budget.

ISSUE BACKGROUND

Area residents forwarded a petition, signed by the majority of affected households on both sides of Old Burnhamthorpe Road between Indianola Drive and Embers Drive, requesting Transportation Services to remove a portion of the existing "No Parking Anytime" regulation currently posted on both sides of the street. A map of the area is Attachment 1.

COMMENTS

Old Burnhamthorpe Road, in the area of Embers Drive and Indianola Drive, is a 9.7 metres wide road classified in the City's road system as a "Local" road. There are sidewalks on the east side of the street. Currently, parking is prohibited at all times on both sides of Old Burnhamthorpe Road in the area of Embers Drive and Indianola Drive.

Based on the petition signed by the majority of the affected residents and the support of the area Councillor, staff recommends that the current parking regulations on Old Burnhamthorpe Road be amended to allow parking, subject to the City-wide three-hour limit, on the east side (sidewalk side) of Old Burnhamthorpe Road between Indianola Drive and Embers Drive. These changes will have no adverse impact on traffic operation on the street as there is sufficient road width for two-way traffic flow and on-street parking.
