City of Toronto Act, 2006 Public Notice

Municipal Licensing and Standards is proposing that the Council of the City of Toronto adopt substantial amendments to Chapter 591, Noise and amendments to Chapter 441, Fees and Charges.

At its meeting to be held in Committee Room 1 in Toronto City Hall on May 19, 2016 at 9:30 a.m., or as soon as possible thereafter, Licensing and Standards Committee of Toronto City Council will hear in person or by his or her counsel, agent or solicitor, any person who wishes to speak to the matter.

The proposed amendments are subject to the decision of Licensing and Standards Committee and the decision of Toronto City Council. Consequently, the proposed amendments may be modified. Additional or other amendments to the above-noted by-laws, including amendments not contemplated or considered in the proposal by Municipal Licensing and Standards, may occur as a result of the decisions of Licensing and Standards Committee and Toronto City Council.

It is proposed that the by-laws be amended at the Council meeting to be held on June 7, 2016 or at a subsequent meeting.

Municipal Licensing and Standards is proposing that the Council of the City of Toronto:

- 1. Approve amendments to Chapter 591, Noise as described in Attachment 1 of the report (May 5, 2016) from the Executive Director, Municipal Licensing and Standards (Item LS11.2) subject to any stylistic refinements as may be identified by the Executive Director, Municipal Licensing and Standards and the City Solicitor.
- 2. Authorize the City Solicitor, in consultation with the Executive Director, Municipal Licensing and Standards to make an application to the Regional Senior Justice of the Ontario Court of Justice for new and increased set fines for Chapter 591, Noise.
- 3. Approve amendments to Chapter 441, Fees and Charges to permit:
 - a. The collection of one application fee where an exemption to Chapter 591 is sought for multiple, similar events in the same location by the same applicant.
 - b. A waiver of the Chapter 591, Noise exemption application fee for new events in the "Arts in the Parks" and "Music in the Parks" parks permit categories.
- 4. Authorize the City Solicitor to prepare the necessary bill(s) to make such by-law amendments as may be required to give effect to the recommendations in the report.
- 5. Direct that the changes come into force on November 1, 2016.
