

Amendments to Parking Regulations - Kingsmount Park Road

SUMMARY

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to amend parking regulations on Kingsmount Park Road, between Fairmount Crescent and Duvernnet Avenue, so that the regulations will be consistent with parking signage currently posted on the street.

RECOMMENDATIONS

The Manager, Transportation Services, Right of Way Management, Toronto and East York District, recommends that:

1. Toronto and East York Community Council amend the existing parking prohibition in effect on the east side of Kingsmount Park Road, between Duvernnet Avenue and Fairmount Crescent, to be in effect on the west side of Kingsmount Park Road, between Duvernnet Avenue and Fairmount Crescent.
2. Toronto and East York Community Council amend the existing permit parking regulation in effect from 12:01 a.m. to 7:00 a.m. daily on the even (west) side of Kingsmount Park Road, between Duvernnet Avenue and Fairmount Crescent, to be in effect on the odd (east) side of Kingsmount Park Road, between Duvernnet Avenue and Fairmount Crescent.

FINANCIAL IMPACT

There is no financial impact to this proposal.

COMMENTS

Kingsmount Park Road, between Fairmount Crescent and Duvernay Avenue, is a local street operating in a two-way north/southbound direction, on a pavement width of 8.5 metres. There is no TTC Service on Kingsmount Park Road.

The By-laws/Municipal Code indicate that permit parking is in force on the even (west) side of the street from 12:01 a.m. to 7:00 a.m. daily and that parking is prohibited at all times on the odd (east) side of the street. However, during an internal review staff noticed a discrepancy between the existing parking regulations and signage currently posted on the street, as signage indicates that permit parking is in effect from 12:01 a.m. to 7:00 a.m. on the odd (east) side of the street and that parking is prohibited at all times on the west side of the street.

Councillor McMahon was consulted and has indicated that she would prefer that the on-street parking continue to operate as it has for quite some time and that regulations be amended to agree with signage posted. Accordingly, this report seeks Community Council approval to amend the parking By-laws/Municipal Code to ensure they are consistent with signage that is posted on-street.
