2018 Rate Supported Budgets - Solid Waste Management Services and Recommended 2018 Solid Waste Rates

Notice is hereby given that City officials are recommending to Toronto City Council the enactment of a by-law amending the City of Toronto Municipal Code Chapter 441 - Fees and Charges; and any other Municipal Code Chapters as may be required to give effect to the following as of January 1, 2018:

- a 1.0% rate increase to properties that receive Multi-Residential Front-end Container and Multi-Residential Curbside collection services;
- a 2.0% rate increase to all Single Family Residential and Residential Unit Above Commercial (RUAC) properties;
- a 5.2% increase to all other Solid Waste rates and fees currently in Schedule 1 of Appendix A of Chapter 441 (available at: <u>http://www.toronto.ca/legdocs/municode/1184_441-a.pdf</u>), unless otherwise indicated in <u>Appendix A</u> of this Notice.

The attached <u>Appendix A</u> includes all the changes in the recommended 2018 Rates and Fees.

The particulars of the proposed Solid Waste Management Services rates and fees are set out in the report to the Budget Committee of Toronto City Council from the Acting Chief Financial Officer and the General Manager, Solid Waste Management Services entitled "2018 Rate Supported Budgets - Solid Waste Management Services and Recommended 2018 Solid Waste Rates and Fees", (the "Report").

The Budget Committee will make its final recommendations on November 27, 2017, which will be forwarded for consideration by the Executive Committee at its meeting on November 29, 2017 and then to City Council at its meeting on December 6, 7 and 8, 2017.

The adopted fees will be implemented through a by-law that will amend the Municipal Code, if necessary.

While the Report sets out the recommended rates and fee increases, the appropriate Committee may change these recommendations.

Further, Toronto City Council may adopt rates and fees that differ from the recommendations, including rates and fees that are higher or lower than the rates and fees set out in the Report, changes to rates and fees for which no change is recommended, and may adopt additional new rates or fees.
