Teddington Park Residents Association Inc's long-standing advocacy for trees supports the refusal to remove the City tree for driveway or parking purposes. This request is being made on a residential street in Ward 25, the same Ward

TPRA is located. Of interest, it appears from the photos in the staff report that the construction does not conform to COA denial of below grade garage and the landscaping requirements under the inforce zoning by-law 438-86.

Our neighbourhood has had many removals of trees for driveway and parking purposes, without providing for Notice – we now ask why is the TPRA neighbourhood treated differently?
