The Budget Committee will make its final recommendations on May 11, 2017, which will be forwarded for consideration by the Executive Committee at its meeting on May 16, 2017 and then to City Council at its meeting on May 24, 25 and 26, 2017.

While the Operating Variance Report for the Three Month Period Ended March 31, 2017 report sets out the recommended user fee adjustments, the appropriate Committee may change these recommendations.

Further, Toronto City Council may adopt user fees that differ from the recommendations, including user fees that are higher or lower than the fees set out in the Report, and may adopt additional new user fees.

The adopted user fee adjustments will be implemented through a by-law that will amend the Municipal Code, if necessary.
