PROPOSAL

The City of Toronto is proposing to adopt an Airport Zoning Regulation (AZR) pursuant to the authority granted to it by the Federal Minister of Transport under the Aeronautics Act to regulate land use in the vicinity of the Hospital for Sick Children and the St. Michael's Hospital helipads. The purpose of the AZR is to ensure that land use is not incompatible with the safe operation of the hospital heliports or the aircraft that use these heliports.
