#### **City-School Boards Advisory Committee Motion**

City Council request the Chair of the City-School Boards Advisory Committee to ask Toronto District School Board staff in Children's Services to report to the next meeting of the City-School Boards Advisory Committee on the capital request/expansion plans for child care and before-and-after school programs in Toronto Schools.



#### Child Care Capital Development Context

- The Ministry of Education (MEDU) has made a commitment to help 100,000 children access licensed child care spaces across the province.
- MEDU frequently takes a schools-first approach to child care capital development by providing funding to school boards for approved projects.
- In addition, the provincial and federal governments have recently provided funding for the expansion of community-based (outside of school) child care programs.



#### Child Care in Schools Capital Expansion Programs

- Since 2015, there have been four provincial capital funding programs that could be used for child care in schools.
- These usually occur in conjunction with broader requests for school capital funding and contain specific criteria for prioritizing schools and eligible expenses.
- These are communicated through "B" memos from the Ministry of Education.

#### School Site Selection and Submission Processes

- There are similarities with all of these capital funding submission development processes
- Service System Managers and school boards are required to work together to identify potential sites where the facility is appropriate and the community need exists
- School boards identify proposed sites based on Ministry of Education and School Board criteria (including space availability, accommodation concerns, and others)
- The City prioritizes sites based on the Child Care Capital Strategy, which looks at the number of spaces available compared to the population of children in an area.
- Children's Services signs an affirmation letter or the Ministry's Joint Submission template, where there is agreement on the need for the project.
- School boards develop and submit proposals with Service System Manager signoff where needed
- The Ministry of Education decides which submissions to fund



## **City-funded Projects**

- Children's Services 10-year capital plan (2018) includes 9 child care capital projects in schools
- Historically the City capital budget has funded projects outside of schools; however an adjustment was made in 2016 to increase access to programs in schools
- School boards were approached to identify sites with sufficient space to create new child care quickly in order to assist in responding to service demand.
- These are subject to City Budget Process
- The City also funds projects outside of schools; the Province has also provided funding for child care centres out of schools, which has been allocated by the City through an application process.

# Before and after School program expansion

- The School Board duty to provide before and after school programs came into effect for last school year
- Programs are in shared space no capital investment required
- Children's Services works with school boards to assess demand, using parent surveys and program registrations
- For the 2017-18 school year, close to 5,000 licensed child care spaces were added
- 2018-19 school year plans are under development, with communication to parents by May
- Key change is the TDSB's plans to directly operate Extended Day Programs before and after school.
