PROPOSAL

In 2016, the City initiated a comprehensive study of the Unilever Precinct area, bounded by Eastern Avenue and the Metrolinx Rail Embankment in the north, the Don Roadway in the west, Lake Shore Boulevard East in the south, and Booth Avenue in the east. In 2015 and 2016, the City received private applications by First Gulf proposing an intensified office and commercial retail development for the Unilever Precinct lands in their ownership, at 21 Don Valley Parkway, 30 Booth Avenue, and 375 and 385 Eastern Avenue.

The proposed Official Plan Amendment would bring forward a Secondary Plan to implement the vision for the Unilever Precinct area that was identified through the comprehensive study. The proposed Official Plan Amendment would also permit the proposed development. It would be subject to approval by the Ministers of Municipal Affairs and Natural Resources and Forestry.

The proposed Zoning By-laws would implement the Secondary Plan vision on the First Gulf lands, subject to a series of Holding ("H") provisions.



Official Plan and Zoning By-law

Amendments Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Official Plan amendment is adopted or refused and/or the Zoning By-law



amendment is passed or refused, the person or public body is not entitled to appeal the decision.
