PROPOSAL

The City of Toronto is proposing to amend Zoning By-law 569-2013, former City of Toronto By-law 438-86; former City of York By-law 1-83; former City of North York By-law 7625; former Town of Leaside By-law 1916; former City of Scarborough Employment Districts Zoning By-law 24982 and Ionview Community Zoning By-law 9089 to facilitate the implementation of the Finch West LRT project, by providing relief from specific requirements for transportation or public transit uses. In addition, further amendments are proposed to previously approved zoning by-laws related to the Eglinton Crosstown LRT project.

Zoning By-law Amendments Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law amendment is passed or refused, the person or public body is not entitled to appeal the decision.

People writing or making presentations at the public meeting: The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.
