## City of Toronto Act, 2006 Public Notice Fees for Solicitor Services (Limiting Distance Agreements)

Toronto City Council will be considering recommendations to adopt amendments to Toronto Municipal Code Chapter 441, Fees and Charges.

It is proposed that the amendments be adopted at the City Council meeting to be held on July 16 and 17, 2019, or at a subsequent meeting. If adopted by City Council, amendments to the City of Toronto Municipal Code Chapter 441, Fees and Charges, will:

1. Add an hourly Solicitor fee of \$231.00 to Appendix C - Schedule 15, Legal Services, for Limiting Distance Agreement drafting and review services.
