# 2020 Rate Supported Budgets – Solid Waste Management Services and Recommended 2020 Solid Waste Rates and Fees

Notice is hereby given that City officials are recommending to Toronto City Council the enactment of a By-law amending the City of Toronto Municipal Code Chapter 441 - Fees and Charges; and any other Municipal Code Chapters as may be required to give effect to the following effective January 1, 2020:

- a 1.5% rate increase to properties that receive Multi-Residential Front End Container and Multi-Residential Curbside collection services;
- a 2.5% rate increase to all Single Family Residential and Residential Units Above Commercial (RUAC) properties;
- a 25% increase in transfer station Tipping Fees; and
- a 6.0% increase to all other Solid Waste rates and fees currently in Schedule 1 of Appendix A of Chapter 441

Any comments received after the Committee meetings will be forwarded to City Council.

The Budget Committee will make its final recommendations on November 25, 2019, which will be forwarded for consideration by the Executive Committee at its meeting on December 11, 2019 and then to City Council at its meeting on December 17 and 18, 2020.

The adopted fees will be implemented through a By-law that will amend the Municipal Code, if necessary.

While the Report sets out the recommended rates and fee increases, the appropriate Committee may change these recommendations.

Further, Toronto City Council may adopt rates and fees that differ from the recommendations, including rates and fees that are higher or lower than the rates and fees set out in the Report, changes to rates and fees for which no change is recommended, and may adopt additional new rates or fees.
