- \$4,468.41 from 108-116 George Street and 234 Adelaide Street East (XR3026-3700016);
- \$14,466.53 from 105 George Street and 252 Adelaide Street East (XR3028-4500093);
- \$103,343.76 from 20 to 26 Lombard Street and 25 Richmond Street East (XR3026-3700825); and
- \$372,721.30 from 177-197 Front Street East (XR3026-3700942).

Funds will be transferred to The Churchwardens of the Cathedral Church of St. James for the installation of heritage lighting. Funds have been received and are being used for their intended purposes. The recipient has been consulted and acknowledges the capacity to spend the funds in the current budget year.
