#### PROPOSAL - PURPOSE AND EFFECT

The City of Toronto is currently undertaking a review of the Official Plan which was adopted by Council in 2002 and came into effect in 2006. After extensive public and stakeholder consultation, Section 3.1.1, Public Realm, Section 3.1.2, Built Form and Section 3.1.3, Built Form - Tall Buildings of the Toronto Official Plan are proposed to be amended to strengthen the existing public realm and built form policies and to provide greater clarity through new policies that describe the public realm, built form and built form types. The proposed policies reflect the continuous evolution of the application of urban design to achieve critical city-building objectives, defining the roles and relationships of the public realm and new development to ensure that buildings and their surrounding public spaces work together to achieve a high standard of design and help create a high quality of life for people of all ages and abilities.

The proposed Official Plan Amendment comprehensively applies a number of the key policies of the Growth Plan including those related to complete communities, complete streets, the provision of a high-quality, vibrant public realm, compact built form and the efficient use of land, the integration of green infrastructure, social equity and quality of life, and a well-connected network of walkable neighbourhoods and destinations that encourage active transportation. The proposed policy changes respond to Council's direction to update the policies in order to respond to the following adopted urban design directions:

- promoting a walkable city;
- clarifying the role of the public realm and the need for new public streets;
- introducing development criteria for low-rise, mid-rise and tall buildings; and
- promoting public squares and Privately Owned Publicly-Accessible Spaces.

The *Planning Act* requires that if an Official Plan is being revised under Section 26 of that *Act*, a Special Public Meeting must be held on any proposed amendments to revise the Official Plan and that an Open House be held if the Official Plan is being revised to ensure that the public has an opportunity to review and ask questions about the information and material made available in advance of the Special Public Meeting. The holding of public hearings on the Official Plan Amendment may be delegated by Council to the Planning and Housing Committee under Section 24 of the *City of Toronto Act*, 2006 and the *Toronto Municipal Code*. The Public Open House for this phase of the Five Year Official Plan Review was held on September 16, 2019.

As part of the City of Toronto's Five Year Official Plan Review, this Official Plan Amendment is in conformity with the Growth Plan for the Greater Golden Horseshoe (2019), is consistent with the Provincial Policy Statement (2014) and has regard to matters of provincial interest under Section 2 of the *Planning Act*. The Official Plan Amendment will be submitted to the Minister of Municipal Affairs and Housing for approval pursuant to Section 26 of the *Planning Act*.

#### DESCRIPTION OF SUBJECT LANDS

The proposed Official Plan Amendment introduces new and revised policies that apply to the entire City of Toronto.

#### **BACKGROUND INFORMATION**

In 2012, City Council directed City Planning to prepare reports containing proposed Official Plan amendments by thematic areas for the Five Year Official Plan and Municipal Comprehensive Reviews under S. 26 of the Planning Act. Since the inception of the Official Plan Review, a number of thematic policy amendments have been adopted by Council.

At their meetings on January 15, 2018 and June 7, 2018, the Planning and Growth Management Committee (PGMC) endorsed draft official plan amendments containing draft public realm and built form policies and a draft terms of reference for a Block Context Plan as the basis for public consultation. The PGMC directed staff to conduct open houses in each community council district, and meet with key stakeholders to obtain comments and feedback regarding the draft revisions.

The Committee directed City Planning staff to hold a statutory public open house and prepare a Final Recommendation Report. The public open house was held on September 16, 2019.
