



# Extension of Permit Parking Hours – High Park Avenue, between Annette Street and Dundas Street West

## SUMMARY

Transportation Services is requesting approval from City Council to extend the permit parking hours on High Park Avenue, between Annette Street and Dundas Street West from 12:01 a.m. to 7:00 a.m., 7 days a week to the new hours of 12:01 a.m. to 7:00 a.m., 7 days a week and 5:00 p.m. to 7:00 p.m., Monday to Friday.

By extending the overnight on-street permit parking hours residents will have improved parking flexibility and the Parking Enforcement Unit, Toronto Police Service, can effectively control long term parking by non-residents through tagging and towing operations.

## RECOMMENDATIONS

The Manager, Permits and Enforcement, Parking recommends that:

1. City Council approve the extension of the overnight on-street permit parking hours on High Park Avenue, between Annette Street and Dundas Street West from 12:01 a.m. to 7:00 a.m., 7 days a week to the new hours of 12:01 a.m. to 7:00 a.m., 7 days a week and 5:00 p.m. to 7:00 p.m., Monday to Friday.

## FINANCIAL IMPACT

The amount of \$600 is available within the Transportation Services 2019 Operating Budget.

## **DECISION HISTORY**

A request was received from Councillor Gord Perks, on behalf of area residents, to extend the overnight on-street permit parking hours on High Park Avenue, between Annette Street and Dundas Street West to address concerns regarding the increase of non-resident parking.

#### COMMENTS

High Park Avenue, between Annette Street and Dundas Street West, is a local street operating in a two-way north/southbound direction, on a pavement width of 12.8 metres. There is TTC Service on High Park Avenue.

Parking is allowed for a 1-hour maximum between the hours of 8:00 a.m. to 6:00 p.m., Monday to Friday on both sides of the roadway. Permit Parking operates between 12:01 a.m. to 7:00 a.m., 7 days a week on both sides of the roadway.

Transportation Services has no objections to extending the permit parking hours of operation High Park Avenue, between Annette Street and Dundas Street West to improve parking flexibility.
